

## **“Savory. Bold. Smoky.”, CONTEST RULES AND REGULATIONS**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

**1. Eligibility:** Sweepstakes (the “Sweepstakes”) is open only to those who enter by texting and who are 21 years old as of the date of entry. The sweepstakes is only open to legal residents of the Continental United States and is void where prohibited by law.
