



## **"A ZEST FOR LIFE: COCKTAIL CONTEST"**

### **Contest Rules and Regulations**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

**1. Eligibility:** Sweepstakes (the "Sweepstakes") is open only to those who sign up at the online sweepstakes page and who are 21 years old as of the date of entry. The sweepstakes is only open to legal residents of the Continental United States and is void where prohibited by law. Employees of 3 Badge Beverage Corporation (the "Sponsor") their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Sweepstakes. Uncle Val's Zested Gin and an image of said cocktail. The entry must fulfill all sweepstakes requirements, as specified, to be eligible to win a prize. Any cocktail recipes that are discovered to be plagiarized will be disqualified. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of 3 Badge Beverage Corporation. You may enter *only once* and you must fill in the information requested. You may not enter more times than indicated by using multiple email addresses, identities or devices in an attempt to circumvent the rules. - Background – The story behind the cocktail/why the creator chose to make this drink
- Authenticity – Originality, ingredients used, etc.
- Appearance – Garnish, ice, type of glass, overall look
- Taste – Mouthfeel, balance

The top 5 cocktails after the first round of judging will be carefully crafted as instructed and evaluated by a panel of 3 Badge Beverage Corporation judges. The overall winner will be

selected by vote. Winners will be notified via email to the email address they entered the Sweepstakes with within five (5) days following the close of Sweepstakes Period. 3 Badge Beverage Corporation shall have no liability for a winner's failure to receive notices due to winners' spam, junk e-mail or other security settings or for winners' provision of incorrect or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within 5 days from the time award notification was sent, or fails to return a completed and executed declaration and releases as required in a timely manner, prize may be forfeited and an alternate winner selected.
